- **December 2024:** Incorporated Tribal Feedback to Revise Draft Systemwide NAGPRA Policy
- **January 17:** Released Second Draft of Systemwide NAGPRA Policy. Sent digital and hard copies to all Tribes on the NAHC Statewide CalNAGPRA Contact List.
